That list could be followed by *The Bishop's Wife*, *White Christmas*, *Holiday Inn*, and *Christmas in Connecticut*. The third tier might include newer movies like *National Lampoon's Christmas Vacation*, *Elf*, *The Polar Express*, and *The Santa Clause*.

*The Santa Clause* is about an ordinary man who accidentally causes Santa Claus to fatally fall from his roof on Christmas Eve. Dave Barrett and Committee brought in well over 1,000 people at the Business Expo.

Chino Valley Lions and Lionesses stepped up and help us continue the Territorial Days Parade and Home Town Christmas.

Johnson says in Peaks and Valleys that in order to stay on a Peak longer, "Be humble and grateful. Do more of what got you there. Keep making things better. Do more for others. Save resources for your upcoming Valleys."

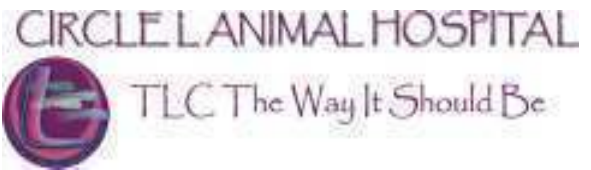

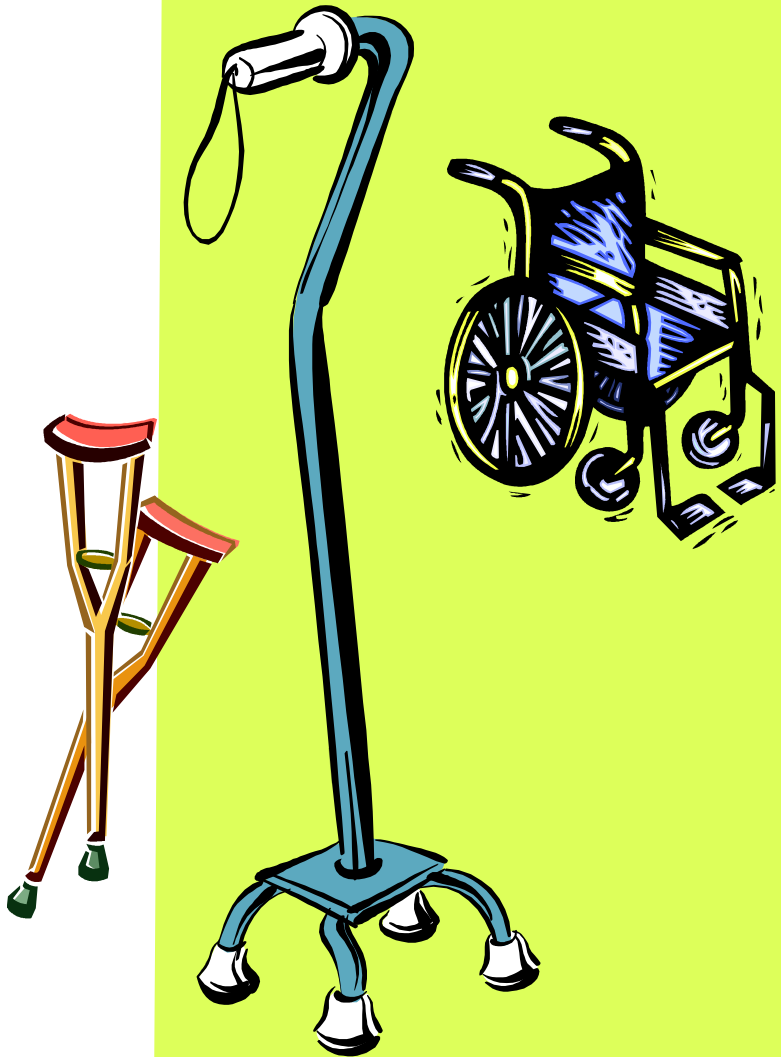
